## 'What if' Mr. Murphy is Lurking?

Speaking about clear and warmer days, that means more people are venturing outside enjoying the environment. Unfortunately, there is an element roaming outside as well looking for opportunities.

Before you venture outside, have a plan and be prepared for the 'what if' scenarios. Mr. Murphy (aka Murphy's Law) is always lurking around the corner. The more prepared you are, the less stress you will encounter and your particular issue(s) can be minimized. While outside, pay attention to your surroundings. Pause when you enter a new location. Observe the topography and the people around you. Are there any natural or unnatural hazards that can impede your progress or cause an accident (driving, on a bike, walking, etc.)? Are you being watched while at the ATM, shopping, at work or school, etc.? Do you have enough space between you and strangers? Has someone closed the distance and is now next to you? Pay attention and get your head out of your cell phone. If someone does get close to you, have you positioned your purse, wallet, laptop bag, etc., in a way that they cannot take it from you? This also includes using the correct body posture and movement. There have been several incidents lately of people being distracted by one individual and another person steals the victims purse, wallet, cell phone, etc. Just some things to think about while outside.

Last February, our Troop went to the USS Midway in San Diego. Here is an account of the trip by one of our newer scouts.

#### I am the pilot of a plane. I dive down almost hitting the water but then come right back up into the air.

My gunner is helping me by shooting down the enemies. My name is Jack Miller and I am a Boy Scout for Troop 37 and I am also a Tenderfoot which is the second rank. I bet you were confused when it sounded like I was flying a plane but it was only a flight simulator. When we visited the San Diego Midway a couple of weeks ago, we had a special VIP tour and I will tell you why it was so amazing.

Across the ship, they have tons of activities that really get you thinking. They have a gift shop, some flight simulators, and they even have tons of the type of planes that they used in the war. You can get a headset to listen to all the facts about the engine, where they sleep, and where they eat. But beware when you turn a corner there might be a dummy that is not meant to surprise you. The dummies are meant to act out the stuff that they did on the ship during World War II. The coolest part is when you go up onto the top of the ship. You can even go inside some of the planes that they flew in the war. They also have people there that were in the war that can educate you about the ship. We spent the night on the ship and we had to wake up at 6:00 in the morning!!! It was a little early but it was so worth it because the breakfast was so good.

When I went to the midway I was not that excited because we had to just stand there while everybody introduced themselves to us. But when we got done doing that, things got a lot more interesting as we explored the ship. If you want to learn a lot about World War II then you should go down there now and start learning and get ready for the experience of a lifetime.

Early Days

Lido Theatre, circa 1938

The good life we all enjoy on Lido Isle is greatly enhanced by the offerings in Lido Village. And while we watch the Lido Village area currently undergoing huge changes, it's fun to look back at its beginnings. While Lido Isle began its history in 1928, this photo



shows that Lido Village started its development around ten years later. A very lonely Lido Theatre, circa 1938, was a harbinger of things to come. After 81 years, the theatre still serves as a major draw to this area.

The other building that was a mainstay of the Lido Village area was Newport Beach City Hall, opened in 1945. Old Isle found this preliminary artistic rendering for City Hall, dated 1941 (and thank you to Sherman Gardens Library for this interesting document). The only other building shown in the rendering is a very small Lido Theatre, so these two buildings really formed the backbone of Lido Village in the early days. The City Hall, as most of us know, stood for over 70 years at the corner of Newport Blvd. and 32nd St., now the home of the Lido House Hotel. But it appears that the 32nd St. name was not in use in the early 1940s. Instead, the street's name on the rendering appears as "The Hudson". So, do give that a thought when you drive over to Von's! ## **Disaster Preparedness Opportunities:** PAST AND FUTURE by Gail Reisman

Few communities are as active as Lido Isle in helping their residents prepare for and respond to emergencies.

In January, Lido Isle and the Newport Beach Fire Department offered Lido residents a class titled What to Do After You Call 911.





At the class, Life Safety Specialist Matt Brisbois discussed the importance of individual and community disaster preparedness. He then reviewed the importance of initiating basic care after calling 911 and demonstrated how to do hands-only CPR and how to control severe bleeding. Under the direction of Life Safety Specialist Raymi Wun, Fire Captain Charlie Dall, Fire Engineer Richard

> Ruffini and Fire Paramedic Joel Chidley, participants practiced the evening's lessons. If

you weren't at this class, we missed you and hope you can attend when we offer it again.

## State & Federal Laws Protect ALL Native Birds


The Migratory Bird Treaty Act (MBTA) is one of the nation's oldest environmental laws passed in 1918. Under the provisions of the MBTA, it is unlawful "by any means or manner to pursue, hunt, take, capture (or) kill" any migratory birds except as permitted by regulations issued by the U.S. Fish and Wildlife Service (FWS). The term "take" is defined by FWS regulation to mean to "pursue, hunt, shoot, wound, kill, trap, capture or collect" any migratory bird or any part, nest or egg of any migratory bird covered by the conventions, or to attempt those activities. Migratory birds include all native birds in the United States, except those non-migratory species such as quail, that are managed by individual states. California Fish and Game Code Section 3513 provides protection to the birds listed under the MBTA, essentially all native birds. Other Fish and Game Codes provide further protection to certain types of birds, such as raptors.

#### **ALL NATIVE BIRDS ARE PROTECTED**

Since only a few birds encountered in the City of Newport Beach are not protected (e.g. European starlings and house sparrows), it is safe to assume that any nest you encounter should be avoided.

TIP:

Conduct brush removal, tree trimming, building demolition, or grading activities outside of the nesting season. California Department of Fish and Wildlife biologists have defined the nesting season as February 1st through August 15th.

### June 26, 1944 – January 25, 2019

Leonore Butcher has left this world and gone to join her beloved mother, Ivis Chrisman, following her long journey (as she called it) with cancer. With her family surrounding her, she passed on the morning of January 25th. In 1984 at the age of 40, she was diagnosed with breast cancer, and at the age of 60 with cancer in her lungs. She was a valiant fighter and a model of great strength to others fighting their own battles. In 1962, she married Vince Tramontano. They lived in Covina and had five children together. In 1979, they divorced and Leonore moved to South Pasadena with her mother and her two youngest twin sons. She met Russell Butcher in 1987 on the South Pasadena Little League field at the hot dog stand after bringing her twins and Russell's son to the

game. Leonore and Russell were married in 1989 and a few short years later opened the Bissell House Bed & Breakfast South Pas.

With their children all married and with families of their own, Leonore and Russell moved to Lido Isle in 2007 where they have resided since. Leonore was active in LIYC, President of the Women's Club, founding member of the Prayer Group and a regular at Cheap Chicks poker games. She initiated and produced two talent shows raising funds for Wounded Warriors at Camp Pendleton, started the annual "Friendsgiving" and took up tap dancing in her late 60s. She tapped in several musicals at BCYC. She loved to travel but also enjoyed returning home. She loved to celebrate and

dance and brought light into every room she entered. She had a magnetic personality that drew others to her, was non-judgmental, forgiving and radiated love. To her, kindness was effortless. As a child, Leonore attended Self Realization Fellowship in Hollywood which gave her a strong foundation for her faith throughout her life. She believed that we all have our lessons to learn and we must learn them by ourselves, at our own pace. She was a strong believer in prayer and believed that if she asked Jesus, she would receive an answer.

Leonore graduated from Fullerton College as an RN and worked at White Memorial Hospital for several years. She then started her own company, LTB Consulting, preparing hospitals for their Joint Commission Surveys. They always passed. Leonore will be dearly missed, as she brought hope and love into the hearts of everyone she met. She is survived by her husband, Russell, her children, Donna MacLellan (Don), Loren Tramontano (Monique), Andrea Hanna (Nick), Chris Tramontano (Mary), Nick Tramontano (Regan), and her stepchildren, Greg Butcher, Jennifer Candland (Matt), Becky Stansbury (Trevor), and Brian Butcher (Anne). She had 28 grandchildren and 3 great-grandchildren. If everyone on earth was like Leonore, then God's work would be done.

## Lido Isle Community Association Board of Directors' Meeting Open Session - March 13, 2019

#### **CALL TO ORDER**

Quentin called the meeting to order at 6:02 pm

#### PUBLIC COMMENT SESSION

A resident came in to speak with the Board in regards to signage they would like to place up on the city side of the Lido Bridge as well as on the Lido Isle side to promote a cause they are supporting and currently a part of. Residents came in to discuss adding an elevator to their home that was previously denied by the Architectural Committee and also brought with them their Architect for the project. They came in to ask for an exception from the Board due to medical reasons and brought in plans as well as pictures to show the Board the elevator cannot be seen from the street or from the Bay. The Board will discuss this during the Action Items section of the meeting since they are included on this agenda. Another resident came in to speak with the Board to inform them of a meeting on April 6th that Michelle Steele, a County Supervisor, is holding regarding a change to the fixed base operation at John Wayne Airport. The resident would like to place an ad in the Islander to inform Lido residents of this aviation matter in hopes of members attending this meeting. The resident went on to inform the Board there will be multiple alternatives discussed at this meeting and the first two would include a new terminal for private jets that can operate 24 hours a day and one of those would include a new customs area for international travel. A resident came in to discuss the median project currently in place for the beautification of the Piazza Lido medians by the MCIC. This resident disagrees with the project and feels more residents should have been informed of the project since the Island is affected, not just those surrounding the medians. Dave Rahn, MCIC Chair, discussed the project with the resident and provided a full history of the project through the MCIC to this point.

#### MINUTES

Leslie made a motion to approve the February 13, 2019 Board minutes as written. The motion was seconded by Marion and passed.

#### **MANAGER'S REPORT**

#### Escrow Report:

There have been 3 escrows opened in 2019 with 1 closed. For the same period in 2018, there were 3 escrows opened with 3 closed and 0 canceled.

#### Clubhouse Audio Visual Equipment Upgrades:

New audio-visual equipment has been installed in the AV closet located in the Garden Room as well as a new lpad installed in the wall of the Bay Room as a new control panel for each room of the Clubhouse. The AV equipment installed is from the previously approved expenditure by the Board of Directors.

#### Annual Meeting:

As of today (March 8, 2019), the LICA office has tabulated a total of 363 votes out of 441 needed for a quorum for the 2019 BOD Election. A second mailing to those who have not voted will go out the week of the Board meeting and signs reminding residents to please vote. As a reminder the Annual Meeting will be held on April 13th starting at 10am but LICA will provide coffee and breakfast items beginning at 9:30am. Justin will be sending out information pertaining to the Organizational Meeting to potential new Board members who are currently on the ballot as well as the current Board members continuing on for another year for 2019-2020. Just will also provide information to future Board members on the ballot informing them of some of the operational procedures to expect while serving on the Board.

#### Maintenance Technician Position:

Sean McCabe was terminated from his position in February and LICA Management has been active in finding a replacement for the Maintenance Technician position. Matt and Justin have performed four interviews and so far have found one candidate they have invited back for a second interview. Once the candidate has been chosen by LICA Management, they will then introduce the candidate to the Admin Committee of the Board for final approval.

#### Creeping Fig Removal from Clubhouse and New Palapa Fronds:

Leslie Thompson has approved a bid to remove the creeping fig previously approved by the Board and the project will start on March 29th of this year. The dilapidated palm fronds of the Palapas on the LICA beach have been approved for replacement and the project should be completed soon.

#### **ASSISTANT MANAGER'S REPORT**

Item E. Juli made a motion to approve the installation of a sixty inch flat screen TV in the Board room for presentation purposes. The TV will not have any capability of television programming from cable or satellite but will in the future have internet connected to allow for presentations. The motion continues that the amount will not exceed the bid amount of \$2634.83 and Justin from LICA management will reach out to Konex AV to see if they can find the same TV listed but at a reduced price. The motion was seconded by Mike and passed.

Item F. Juli made a motion to allow an exception for the installation of an outdoor elevator to a resident's home after the ARC initially denied the request. The motion was seconded by Mike and a vote was then taken. The motion passed with a count of 4 in favor, 3 not in favor and one Board member abstaining.

Item G. Juli made a motion to authorize a residents request for a beach wedding on October 19th, 2019. The motion included the approval of the usage between 1pm and 4pm. The motion was seconded by Scott and passed.

Item H. Juli made a motion to authorize a beach wedding on October 12th, 2019 which also included the denial of their request to move the swim float as well as the denial of a temporary screen lining the street along the grass areas of the beach. The motion included the approval of the beach usage between 2:30pm and 6pm.The motion was seconded by Dave and passed.

#### **COMMITTEE REPORTS**

#### CC&R's & By-Laws:

Leslie updated the Board on all Architectural Committee matters and informed them the Committee is working on updating Directive #6.

#### CC&R's & Bv-Laws:

Dave Rahn informed the Board of his idea to reach out to possible new Board members on the current ballot to inform them of how the Organizational meeting works at the Annual meeting and more details as to what the positions entail. He also felt it is a good idea to inform those nominees as to the current list of Board members who will be continuing on with the Board and their rolls with the current committees.

#### **City Relations:**

The Board discussed the recent request to the city of Newport Beach to raise their hedge heights from forty two inches to come in to alignment with Lido Isles current hedge height limit of sixty inches. The city discussed this matter on the phone with LICA Association Manager, Justin Langenberg, and requested the Board consider an all Island survey to go out requesting this increase. The city informed Justin city council will only consider the idea if there is an "overwhelming response" from the members of the Island. The Board was informed of this conversation and decided that something similar to this idea has already been performed when the Island decided to move forward with a possible CC&R change for Lido Isle raising their hedge heights from thirty inches to sixty inches back in 2002. The Island voted to change the CC&R and the height was then raised to sixty inches. The Board will now form a firm letter in conjunction with LICA management to inform them this should suffice in their request and would like to move forward with their current request for the city to raise their hedge heights to sixty inches for Lido Isle.

#### **Communications/Website:**

Shana discussed her email exchange with David Cane, LICA legal counsel, pertaining to the website directory of members. She read the email to the Board from David Cane describing in detail the process all members must go through per the Davis-Sterling Act to obtain a membership roster. A request for a copy of the membership roster must be made in writing, Civil Code Section 5225. The written request must state the purpose for which the roster will be used and that purpose must be related to the requestor's interest as a member. Civil Code Section 5230 prohibits selling a roster, using a membership roster for commercial purposes, and using a roster for a purpose unrelated to a person's interests as a member. The only information that is to be provided in the roster are the names, property addresses and mailing addresses of all members who have not otherwise opted out of having their information shared, Civil Code 5220. No email addresses, no phone numbers, no account numbers are to be provided. Associations have 10 business days to provide a roster following a lawful request.

#### LANDSCAPE:

Marion discussed the landscape design at the Koron/Soud street end park previously discussed in the Action Items area of the Board meeting.

#### MCIC:

Dave informed the Board he has recently been informed by the Playground equipment replacement Company that LICA's swing sets are currently out of compliance. He said they will have to replace the swings and has been working with the vendor to come up with an acceptable reconfiguration at the San Remo Park Tot Lot to ensure LICA is in compliance after the project has been completed. He will also place the two bids for brand new playground equipment for the Genoa/Soud playground on the next Board agenda for approval. The equipment is slated for replacement through the Reserve Study.

#### PRIOR EXECUTIVE SESSION DISCLOSURE (February, 2019)

Quentin called the Executive Session to order at 9:28pm.

Discussion Item A. The Board discussed Island wide Strada issues and in particular possible lawsuits pertaining to hedge heights between neighbors.

The Board will reconsider the approval once they have the full tennis pro insurance documents detailing the coverage, have determined whether the tennis pro should be considered an employee or an independent contractor after speaking with LICA counsel for determination, have determined what percentage of LICA members will be needed to allow for clinics of more than one person and finally to require the tennis pro to provide LICA management monthly reports of who they are training including all members and non-members.

Item D. The Board denied the idea to provide sunscreen station around the Clubhouse and patio area of LICA.

#### **ACTIVITY REPORT**

#### San Remo Park Project

- Financial Report: The Committee reviewed a new combined estimated and actual expense report. We 1. have a positive \$13,580 overall budget variance as of February 25, 2019.
- Design/Construction Update: The following activity occurred during January: 2.
  - a. Landscape plans have been approved by the City of Newport Beach.

- b. CERT/Garage Building plans were resubmitted on 7/25 for final city approval. We expect to have final approval of the plans within 7-14 days.
- San Remo Project Timeline: We are on schedule. The distribution of plans to bidding contractors 3. should occur during the March 1-15 timeframe.
- Playground Equipment: Vicki reported on her discussions with Sun Country Systems President, Tim 4. Hollinger, on the colors of the various components. During their discussion, Vicki learned that the planned location of the new play structure and the existing swing set does not meet current safety codes. She discussed alternatives with Tim and he produced an updated plan that complied with the regulations. This plan swapped the locations of the new play structure and swings. Vicki's meeting also resulted in the following:

#### a. Updated Plans:

- Defining that the park's design is geared primarily toward young children ages 2-5. i.
- The park's updated design will use the same new basic play structure we selected ii. with some minor modifications to remove the drums and add some ships wheels. It was also suggested that we add a "fireman's pole" if it will fit in the space we have available
- iii. Adding a new two seat swing set and selecting a swing chair design since the currently used bucket chairs are no longer considered safe by the regulators.
- b. Playground Surface: During her conversations with Sun County's President he suggested that we consider using artificial turf over three inches of foam under the play equipment rather than the foam only product we originally specified. The advantages of using artificial turf are:
  - i. That it comes with an 8 year warranty, instead of 3 years for the foam only option,
  - It has a total of 5 inches of protection, instead of 1 inch for the foam only option, and, ii.
  - It has an installation cost of \$11,000 compared to \$12,000 for the foam only option. iii.

The committee unanimously agreed with the play structure changes, endorsed using artificial turf and asked for some additional information on the two of the three swing chair designs before making that selection. The overall cost change is expected to add \$3,000-\$4000 in costs to this project. Dave will contact Urban Arena to let them know about the changes and ask them to verify directly with Sun Country that all the measurements on their plans conform to our plans and make any necessary changes.

Antibes/Piazza Median Rehabilitation:

- 1. Plant Choices: Several members of the committee would like to substitute the bird of paradise plants shown in earlier Antibes design with some other type of plant. Urban Arena has agreed to produce plans for these medians using low water use plants that will meet the LICA's preferences and that meet the City's requirements if possible.
- 2. Median Plan Changes: ParkWest produced the plans for the Antibes and Piazza medians incorporating the changes required by the city. These plans were approved by the Board. However, the City has determined that these plans are not acceptable for their use. It was reported that the Board approved hiring Urban Arena to further develop the median plans using the PW plans as concepts.
- 3. Median Encroachment Permits: It was reported that work continues with the city on completing the application for a "Master Encroachment Permit" covering the Genoa/Piazza medians, the Antibes median, The Via Genoa Triangle median and the San Remo median. At this point both parties are focused on getting final landscape plans for the Piazza and Antibes medians which are required to support the encroachment permit request.
- 4. Neighbor's Meeting: Dave and Marion Smith, Landscape Committee Chair are presenting to a group of Piazza Lido homeowners on February 26 the challenges of rehabilitating the Piazza medians and a final concept plan.
- 5. Median Curb Replacement: Dave met with the city staff on site at the western most Piazza median to discuss the city replacing the broken curbs prior to LICA doing any work in the median. The city has indicated that they will likely replace the broken curbing sometime in mid-March.

Five End Park Rehabilitations: Due to the seemingly overlapping responsibilities of the MCIC and the Landscape Committee at times, a brief discussion occurred to clarify the Landscape Committee's role as the project leader in rehabilitating the landscaping and walkways in five of the end parks.
