



# Attn: Lido Seniors & Caregivers

Many of us dream of staying on Lido "forever" but without planning and preparation, a major disaster can turn our dream into a nightmare.

Seniors and others with physical or cognitive disabilities face additional challenges beyond a disaster's initial damage and injuries. The best response may be to leave your home and stay temporarily at a shelter or with an off-island friend or family member.

If you are an older adult with health issues or a disability, here are some measures that will assure the best outcome after an evacuation:

- Do you use a motorized wheelchair? If so, have a manual wheelchair and/or walker as a backup.
- Do you take medicine or require a daily medical routine? Pre-pack enough prescription medications and consumable medical supplies to last at least a week. Rotate your supply periodically so it remains up-to-date.
- If you are not able to obtain an emergency supply, always fill prescriptions on the first day they eligible for a refill, rather than waiting until the day you run out.
- Make provisions for medications that require refrigeration.
- When you evacuate, bring written copies of your prescriptions and over-thecounter medications (including dosage and allergy information). Also, take a list of the type and model numbers of any medical devices you require.
- Consider making electronic copies of important information on a flash drive. Even if you don't use a computer, this could be useful for others.
- Put specialized items in your ready-to-go kit, including extra wheelchair batteries, oxygen, catheters, eyeglasses, hearing aids and hearing aid batteries, and food for service animals.
- If you receive assistance from professional caregivers, ask if they will be available to care for you if you must relocate.
- If you undergo routine treatments administered by a clinic or hospital or if you receive regular services such as home health care, treatments or transportation, talk to the service provider about their emergency plans.

If you are a caregiver for someone with Alzheimer's or a related dementia make sure he or she always wears an ID bracelet. Here are other things to include while packing supplies:

- a familiar, comforting item such as a pillow or stuffed animal
- favorite snacks and high-nutrient drinks
- incontinence undergarments, wipes, and lotions
- physicians' names and phone numbers
- a recent photo in case you get separated

#### Matt's Corner: Lido Isle Boat Gardens

Happy 4th of July to everyone. Summer is finally here and in full swing. Get all your boats into the water and enjoy this beautiful bay. Tidying up the boat gardens – LICA has painted a few new spots in the Genoa East Boat Garden to help with additional sabots. As the staff moves through its transition with the Grand Manors we will be revisiting standards for the boats already in the storage facilities.



All dry storage boats must be stored on a trailer, dolly or rack. The entire boat and dolly or trailer, including all protrusions, must fit within the assigned space. Only one approved boat may be stored within an assigned space, except up to two jet skis may be stored alongside each other on a single trailer. No boats may be stored above each other except on approved racks provided, owned and maintained by LICA. Larger spaces may be used for undersized boats only at the sole discretion of LICA.

All dry boats must be protected by fitted covers in good repair secured to prevent the boats from filling with water or debris. Plastic covers, other than those fitted specifically for the boat, are not allowed. Sabots must be stored upside down when not being used on a regular basis.

Dollies, trailers and wheels must be rust free and in good operating order. Tires are to be kept fully inflated.

Let's work together to keep Lido Isle the gem of the bay!

exploring the history of Lido Isle, sometimes explore the history of the world. In this instance, Old Isle has been fascinated to delve into the life of Ladislaw (Laddie) Reday, formerly of 359 Via Lido Soud. Reday, a longtime Lido resident, passed away in 1987, but his actions during World War II will always endure. American Army Second Lieutenant Reday helped form a group in Australia called the

US Army Small Ships Section. The idea was to recruit as many Australian small ships and crews as possible to ferry American troops and supplies to and from New Guinea to assist in the efforts to fight the Japanese after damage to the US Navy in the Battle of the Coral Sea. (This episode in war history is the basis for the 1960 film, "The Wackiest Ship in the Army").

Reday kept notes on his many exploits in Australia and New Guinea, only to have them float away on a landing craft that was damaged by Japanese planes on New Guinea's Morobe River. Reday's writings were returned to him almost 30 years later by an Australian serviceman, and form the basis for the book "The Raggle Taggle Fleet", which was published posthumously in 2004. Not an easy volume to obtain (check eBay), but sounds like an interesting read. Also, online you can find a vintage 1946 Esquire article written by Reday on the pleasures of "jungle punch", entitled "Remembering Combat Cheer". Old Isle is happy to remember and honor the exploits of Laddie Reday.



**GENOA WEST DOCK** is now open for the trial period of June 17, 2019 through December 11, 2019 for cleaning and minor repairs of LICA member vessels.

#### **GENOA WEST DOCK:**

#### **CLEANING AND MINOR REPAIRS OF VESSELS**

Residents have requested use of space at LICA for washing of boats, especially those that are on moorings in the bay. To that end, the LICA board has approved the following *immediately for a 6-month trial period*. Yachtsman should review Policy/Procedure Directive 9: Rules for the use of Clubhouse and all other LICA Docking Facilities on the LICA website or request a copy from LICA so they are familiar with the directive.

During this time Directive 9 (is followed as it stands now) and at the end of 6 months, it will be evaluated for an update with these changes herein.

#### **Guidelines for Trial:**

- The use of Genoa West is for LICA members "in good standing" only. No guests/reciprocal privileges may use Genoa West under any circumstances of this trial.
- Permitted services can only be undertaken at Genoa West and the Yachtsman must make an appointment with LICA and submit a completed \*Docking Facility Policy and Agreement Form that is kept on file. The office will schedule your requested time.
- The Yachtsman is responsible for their third-party vendors whom they allow to have access to the dock for work purposes. In addition, vendors must complete the Docking Facility Policy and Agreement Form and make sure they are familiar with the Directive 9 rules that pertain to "cleaning and minor repairs". The LICA office shall have the authority to prohibit any service vendor from providing further services after one or more warnings for failure to comply with any of the guidelines.
- Permitted services include vessel cleaning, power washes, complete detailing/waxing and minor repairs. No major repairs shall be conducted on any Lido docking facility that violates LICA/LIYC rules or directives or services, that violate federal, state or local law. No service is allowed that creates unnecessary noise, dust or runoff per discretion of the LICA office.
- The Yachtsman will make his request for docking time with LICA.
- Facilities may be used in two (2) hour increments, not to exceed a twenty-four hour total. Regardless of advance registration no docking may occur in inclement weather or in wind conditions above 15 knots. Due to Genoa West Dock capacity maximum yacht size may not exceed fifty-five feet in total length. In rare circumstances or in lieu of major detail of large vessels LICA may allow one overnight stay to allow completion of work which will be counted against the total number of permitted overnight stays on the LICA clubhouse dock (currently 7 per month). At no time may the Yachtsman or guests sleep overnight at the Genoa dock.
- Should your service complete sooner than expected or need to be rescheduled a courtesy call to the LICA main office is appreciated so other members may enjoy this privilege.
- Service hours are Monday-Friday 7AM to 6:00 PM. No reservations/services will be permitted on a weekend or major holiday which are: Memorial Day Weekend (Friday through Monday), July 3rd and July 4th, Labor Day, Thanksgiving Day and the day after, Christmas Eve and Christmas Day, no overnights during Newport Beach Boat Parade week.
- Authorized users of Genoa West Dock must haul away their own trash and/ or drive down and dispose of trash in the large dumpster at east end of the Clubhouse

\*A copy of your valid Marine Certificate or DMV registration and proof of adequate insurance naming LICA additional insured is required for the agreement forms and may be reviewed at any time.






## Saturday in the Park





#### San Remo Park Project

- 1. Design/Construction Update: The City planning staff noted that the square footage ratio of the openings, such as doors and windows, to the square footage of the floor plan was not in compliance with City codes. To achieve compliance the door widths need to be narrowed to 2 foot 6 inches from the original 3 foot width in the plans. After a review by CERT committee member Ken Wirgler, it was decided that narrowing the doors would not affect the intended use of the building. Dave has notified Urban Arena to make the change to the plans and resubmit them to the city for, hopefully, final approval since this is the last open item with the plans. Follow-up continues on a regular basis. No other work is occurring on this project until the plans have been approved by the City.
- 2. Playground Equipment: Vicki reported on her updated discussions with Sun Country Systems President, Tim Hollinger. Sun Country has produced an updated playground plan that through a modest re-engineering of the site plan, adds swings back into the plan.
- 3. San Remo Project Timeline: The committee was informed that the planning delays have used up our 90 day contingency period. The distribution of plans to bidding contractors is now scheduled to occur during late June. The additional planning delays may cause a delay in starting the project to October or November which could impact its completion date currently scheduled for early second quarter 2020. Plans will be submitted to our potential contractors as soon as they are approved and all contractors will be asked to submit their bids in 30 days or less to assist in starting the project in early September as originally forecasted.

#### **Genoa Park Rehabilitation Project:**

Genoa Committee Report: MCIC member and head of the Genoa Park Playground committee, Vicki Barns, reviewed the new playground equipment that has been planned for this park. She reported on discussions that she has had with neighbors regarding this project. She shared renderings of the equipment.

#### **Antibes and Piazza Median Projects:**

"Master Design Palette": Dave proposed that the Committee members consider adopting "master plant and design standards" as proposed by some residents. The "palette" would be used to guide LICA in the choice of plants and paving surfaces for areas being redeveloped as MCIC projects, and for consideration by the Landscape Committee for their projects. The committee reviewed past and recently proposed landscape renderings of the Piazza Lido medians and the Antibes median for ideas. The committee determined that with the plants and paving surfaces already specified for San Remo Park and the paving specified for the Antibes median, which were was chosen to match the recently completed outdoor deck areas of the clubhouse, that a design standard was organically emerging. The decision was unanimously adopted to modify earlier prepared Antibes median plans to incorporate the same planting materials specified for San Remo. Dave agreed to have Urban Arena to update our Antibes plans. If possible, Dave hopes to present the updated plans to the City for their comment prior to the June 12 Board meeting to obtain the Board's approval on the designs so bidding on this project can be added into the bidding process for San Remo park to gain some economies of scale.

The committee also asked that Urban Arena document this master design palette for use in other projects on a consistent basis.

- 2. Piazza Lido Median Rehabilitation: No changes from last report.
- 3. Antibes Median Rehabilitation: See "Master Design Palette" above.
- 4. Median Encroachment Permits: At this point the City and LICA continue to be focused on getting final landscape plans for the Piazza and Antibes medians approved by the city and the Board since these plans are required to support the encroachment permit request. Work on the Master Encroachment Permit language will restart after the designs are finalized.
