What do you see when you look out at our beautiful Bay?



Most likely, it will be Harbor 20s gliding by. Yes, Harbor 20s are the most popular boat in the Bay, with more than two hundred of them registered. And, it is for good reason, because they are comfortable with soft foam seats, can seat up to six adults, have a built-in ice chest and cup holders, and are easy to sail.

These boats were conceived back in the mid-1990s by a small group of avid sailors at Newport Harbor Yacht Club. It all started in the Pirates Den with sketches on paper napkins. These sailors wanted a boat that was easy to rig and sail, would fit neatly into the Bay venue, and offered comfort not found in other boats of the day. Since they had all sailed Etchels and other competitive boats, they wanted a boat that would sail well and be fast enough for racing. They had Steve Schock design the boat to fit their concept, and brother Tom of W.D. Schock Corporation to build them. They were an immediate success, and the sail numbers have reached to

over 600. There are several other Fleets, including Santa Barbara, Hilton Head and Annapolis which have exchange regattas with the local fleet.

#### A TALE OF TWO ARCHITECTS

One of the most distinguished architects to have worked on Lido Isle was Richard Neutra, and Old Isle has previously written about the Pickering house which he designed circa 1960 at 225 Via Genoa. Neutra, born in Austria, is incredibly famous for his modernist-style houses, mostly built in southern California in the 1950s and 60s. In our previous article, we only had access to one photo of Pickering House. We have subsequently uncovered a few more images from the Julius Shulman archive at the J. Paul Getty Trust that we are excited to share. Shulman himself was one of the most prominent photographers of mid-century and later architecture, so it is great to be able to take a look at his work as well.

And speaking of prominent architects, Lido Isle almost became a close neighbor to a Frank Gehry apartment building. Old Isle became aware of an architectural sketch showing that Gehry designed an apartment building in 1963 for 3300 Via Lido, right off the Lido Bridge where the Windward Sailing Club currently stands. The building obviously was never built, but interesting to know of our possible proximity to architectural greatness. #### LIDO ISLE SECURITY NEWS

Hello Neighbors... This security article for November will be dedicated to reminding all of you some basic crime prevention and safety techniques involving your home. Unfortunately, there have been some incidents lately on Lido Isle and other Newport Beach communities.

I cannot stress enough to lock your doors, secure your windows and close your garage door if unattended (while in your garage, your situational awareness should be on). Before you retire for the evening, conduct a sweep of your home and make sure everything is locked and secure.

Please find the following home security tips from the Newport Beach Police Department. Of course things will vary depending on your personal lifestyle.

- Always lock your windows and doors when you go out, even if for only a few minutes. Second story windows & doors should be secured as if they were on the first story.
- If you return home and find your pedestrian door that leads into your home locked, and you are certain that you left it unlocked, DO NOT GO INSIDE! Call 9-1-1 ~ Burglars often lock this door to slow down a victim, allowing the burglar extra time to get out of the home before the resident enters.
- If your home is equipped with an alarm, always activate it even if you're only going out for a short walk.
- Consider adding a motion sensor in your master bedroom/ bathroom, which will activate the alarm if someone comes in through a glass window or door without opening it.
- Always keep your front and rear porch lights on from dusk to dawn and use motion detector lighting along the sides of your home or areas with little foot traffic.
- **Use timers** on indoor lamps to give the appearance that you are home.
- Adjust window coverings for optimal privacy while maintaining good visibility outside.
- Assess whether or not a window can be easily accessed from a tree, balcony, roof, wall, or with patio furniture and adjust your security plan accordingly. Ladders should be stored inside or locked to a stationary object.
- If your garage door has a remote shutoff button on the wall-mounted control, located in the garage, consider locking the door nightly. This will prevent your garage door from being opened remotely.
- If you have a safe, make sure that it is properly bolted to concrete so that it cannot be easily removed.
- Always close and lock your safe and never leave a key or combination out or in an easy to find location (i.e. office, nightstand, etc.).
- When you leave on vacation, remember to call the Police Department for a "Vacation Check" at 949-644-3681. Also, ask a trusted friend or neighbor to pick up your newspaper and mail while you are away.

Report all suspicious activity by calling the Newport Beach Police Department at 949-644-3717.

On a positive note, have a Happy Thanksgiving and enjoy the holiday. If you plan on attending Black Friday, pay attention, be safe and good luck shopping. All the best!

This past month, however, work began on improvements to the Park. The result will be a more enjoyable recreation area and an improved Emergency Response location including a larger CERT shed.

Regrettably and unavoidably, because of the condition of the property and the demolition of the current CERT shed, our Staging Area and supplies will not be available until the Park is completed and the shed is reconstructed and stocked...in 4 or 5 months.

If a disaster occurs during this time, you will be more responsible than previously for yourself, your family and ideally, for your neighbors.

How should you prepare? By assembling a disaster kit now and by downloading the Red Cross First Aid App. Encourage your neighbors to do the same.

# INTRODUCTION TO THE GRANDMANORS RESIDENT PORTAL


Welcome to the GrandManors Resident Portal! All residents in communities managed by GrandManors have access to the GrandManors Resident Portal. The following tutorial is designed to introduce you to the Portal, the information available to you on the portal, and how to locate the information you are looking for, so let's get started!

#### Registering Your New Account and Logging In

- To log onto the Resident Portal, please visit https://www.grandmanors.com/resident-services/. Click on the "Log In" button to log in.
- Once you click on the "Log In" button, you will arrive at the log in screen. Enter your User Name and Password in the appropriate fields. On your first visit to the portal, click on the "Don't have an account" link below to create your new account:
- What you will need to register on the Resident Portal:
  - Association ID: Typically an 8-digit association ID
  - Customer ID: A 16-digit account number beginning with an "R"
  - Check Digit: A I-digit security code

This information can be found on on the initial Welcome Letter you receive from GrandManors, as well as any billing statement or coupon (if you cannot locate one, contact GrandManors):

- Forgot Your Log-in Info? If at any time you forget your log in credentials, return to this screen and hit "Retrieve User Name or Validate E-mail Address" to have your credentials resent to you.
- Quick Pay: Once your account is established, as the screen shot above illustrates, you can also make a Quick Payment directly from the main log-in screen. Just click the "Make a Payment" button to make an online payment directly to your account without the need to log in.
- At Your Fingertips: The portal puts a a wealth of association and individual homeowner account information at your fingertips! Once you are logged in, you will find a menu of options available to you. Follow the guide below to learn what each option offers.





#### What can you do in the Portal?

#### Home

The Home screen displays announcements that have been posted by your management team for your information and review.

#### Account Information

On this screen you can view your account number, lot information, assessment, late fee and/or finance charge amounts and due dates, update your mailing address, add new Contacts to your account (i.e., other household members, property managers, etc.) add or modify phone numbers and e-mail addresses for each Contact associated with your account, elect to Opt In or Opt Out of receiving both Standard and Emergency community notifications via e-mail (and text if your association has opted in for our texting feature), and elect to publish your information in the online community directory.

#### Account Statement

Here you may view and/or print an account statement for any date range you choose. Statements can date as far back as the date RealManage began managing your community. You can also view the Open Balance tab which breaks any outstanding balance out by category (assessments, late or finance fees, etc.).

#### View Payment History

All assessment related payments you have made, including dates, can be viewed here to verify if a payment you made was posted to your account. There is also an option to jump ahead to the make a one time payment or set up recurring payments screens (more below).

#### Make a One-Time Payment

This option allows you to submit a one-time payment for your assessment amount, or another amount of your choosing. You'll have the option of paying by via e-check (\$0 processing fee) or credit card (bank processing

fees stated on portal will apply to all credit card payments). This screen also provides the address to which your payments should be sent should you prefer to mail it. Just print out a statement from the Account Statement screen and include it with your check to aid in processing.

#### **Setup Recurring Payments**

Signing up for automatic recurring payments is the simplest method of paying your assessments without every having to worry about sending checks or incurring late fees due to lost or forgotten payments again. You can elect to allow automatic drafting of assessment payments from your checking or savings account on their due date. Please note, select the "Assessment Charges" option to assure the correct amount is withdrawn from your account in the event of a change in the assessment amount. Choose the "Open Balance" option to have any amount open and due on your account drafted (which could also include any special assessment that might be approved in your community and billed to your account). Choose the "Other" option to have another fixed amount withdrawn; please note the amount cannot exceed the current assessment amount; the bank will only withdraw an amount up to but not exceeding the current assessment amount. .

#### **Board of Directors**

A listing of your current Board of Directors with their titles is available here. Contact information is confidential. Should you wish to communicate with your Board, e-mail RealManage and we will forward your request or concern to your Board of Directors on your behalf and advise you of their decision or response.

#### Community Dashboard

On this screen you may view pie charts illustrating financial information and violation information for your community. This includes the status of the association's bank accounts, delinquency matters, expense allocations, and number of residents in and out of compliance with the deed restrictions.

#### **Community Information**

General information regarding access to the amenities at your community, annual and board meetings can be located here, along with contact

information for service providers of your association, can be viewed here. This includes the landscaper, trash removal provider, and insurance agent should you require special insurance certificates for the upcoming sale of your home.

#### **Legal Information**

A summary of key legal requirements per your Governing Documents, such as assessment requirements, meeting requirements, association attorney, and more is available to you here.

#### **Resident Directory**

View a listing of all addresses within the community; you may also view owner names and contact information for those homeowners who elected to publish their information on the Account Information screen.

#### **Community Calendar**

View the general community calendar containing board, annual and special meeting information and other community events. Should your community have amenities available for rental (such as a clubhouse), you may also view current reservations and availability on the Amenity Calendar by clicking on the Amenity tab. This allows you to quickly see if a date you are interested in is available.

#### **My Documents**

On this screen you can view all association documents (legal documents, budgets, forms, meeting minutes, financial reports, etc.). In addition, you can view documents pertaining only to your individual account, such as prior letters or statements that were sent, in the event you misplace them.

#### **Restrictions Summary**

The Restriction Summary provides a summary view of the Use Restrictions for your community in a simplified format. If you aren't sure what the rule is about boats, for example, you can jump straight to Vehicle Parking and view the rule without having to pull out and sift through all the legal documents containing use restrictions for your community. This screen also contains a short-cut to the Report a Violation screen (more below).

#### Report a Violation

On this screen you can report a violation that you have observed in the community. Please be sure to include a photograph as evidence, as violation enforcement cannot be initiated without proper substantiation. While our inspectors will attempt to verify violation reports so the process may begin, they cannot see violations that are in back yards, intermittent, or occur after hours, making date and time-stamped photos a necessity.

#### **Contact Us**

This screen contains a quick way to send a message to RealManage regarding any concern you may have, including account questions, maintenance requests, pool key or gate access requests, and much more, with the option to upload a document pertaining to your request.

#### **Add Property**

Should you own multiple properties in the community or other communities managed by RealManage, you can click on "Add Property" to link those to your Resident Portal account so that you may toggle back and forth between them with ease.

#### Download the CircaMobile App

You may also access the Resident Portal through CiraMobile, a feature rich app with much of the same functionality as our cloud-based application, but specifically designed to be easy to read and navigate from your mobile device. CiraMobile is currently available for free download in the Apple App Store. There is both an Apple iPad and Apple iPhone version. Simply search for CiraMobile (spelled as one word).

#### RACE COMMITTEE MADE EASY!

Have you wondered what exactly Race Committee does? LIYC hosts many regattas throughout the year and can only run them successfully with a solid race committee. Many non-sailors hear the term race committee and automatically think "I can't help with that," but here's the good news – you can! There are many jobs helping to run and manage racing that don't require vast knowledge of the sport and once you've handled those, you'll have a better understanding of regatta management in general. Race Committee roles at a regatta include:

**Principal Race Officer (PRO)** – Runs the management of the on-water racing, directs mark set boats where to place the rounding marks and start/finish lines.

**On-Water Scoring** – As sailors come across the finish line, these people (usually 2) write down the sail numbers as the PRO calls them out in order of finishing.

On-Land Scoring - Once the on-water scorers have

finished and compared sheets, a picture is sent to the land scorer to enter into the Sailwave scoring software.

**Mark set Boat** – This person operates a small whaler and adjusts mark location as directed by the PRO. Trophy Set-Up – Work with the trophy chairperson to organize the trophies on display by class.







- **Summary Report Review:** The MCIC members heard an oral summary of the actions necessary to start construction. Open items are:
  - a. Updating the contract scope of work and pricing.
  - Receiving a response to an agreement initiated by LICA regarding the installation of a new 12 foot high GreenScreen fence on the property line and resolving an encroachment of LICA property.
  - c. Redrawing of plans to delete the block wall currently in the plans, incorporating the new GreenScreen replacement fence, installing underground conduits to accommodate the installation of a card key access system to the turf and picnic area, but not the tot lot, and adding some additional security lighting around the CERT Shed/Garage.
  - d. Obtaining an extension on the plan approvals that expired in June 2019. Without this extension LICA will have to restart the plan approval process as if the plans were being submitted for the first time.
- San Remo Playground Equipment: Vicki reported on her updated discussions with Sun Country Systems President.
- San Remo Project Updated Timelines: An estimated start date cannot be determined at this time.

#### Genoa Park Rehabilitation Project:

1. Genoa Park Committee Report: MCIC members and the head of the Genoa Park Playground committee, Vicki Barns, reported that construction on this park is scheduled to start on 11/1 and take approximately two weeks to complete. During this time the areas in which construction is occurring will be secured by temporary fencing. An island wide notice will be sent to all residents about 7 days before the construction starts.

#### Antibes and Piazza Median Projects:

- 1. Antibes and Piazza Lido Median Rehabilitation: Marion Smith, LICA Director, Shelly O'Sullivan, LICA GM, and Dave met with the city regarding these two projects. The City staff approved the plan concept designs approved earlier by the LICA Board.
- 2. Median Encroachment Permits: The city indicated that they would initiate writing the first draft of the master encroachment agreements following negotiations with the City in which they agreed in principal to LICA's request that they fund 50% of cost, up to \$50,000, for the landscaping plants, the irrigation systems and the installation of said materials in the Antibes median. LICA and the City further agreed that the City will be responsible for all tree care in all the medians. LICA agreed to maintain all ground level plantings and irrigation systems.

#### Bridge Entry:

The committee discussed the Bridge entry landscape conditions and inquired about the recent claims regarding the Eucalyptus trees on both sides of the street. The members were reassured that there are no plans by the City or LICA to remove any of the Eucalyptus trees as one resident claimed in a Nextdoor posting.

# INTERESTING FACTS ABOUT AGENDAS & MINUTES: Davis-Stirling Act

**Within 30 Days.** The minutes, minutes proposed for adoption that are marked to indicate draft status, or a summary of the minutes of any meeting of the board of directors of an association, other than an executive session, must be made available to members within 30 calendar days of the meeting. (Civ. Code §4950.)

**Corrections.** Once a draft has been prepared, the Secretary or Recording Secretary can distribute the minutes to the board for review and feedback to the Secretary on any corrections that need to be made. This does not violate the Open Meeting Act because it's not an email discussion. Instead, it is feedback from individual directors to the secretary on corrections and revisions. The draft minutes then go into the board packet for the next meeting for board discussion and approval.

**Distribute Upon Request.** The minutes, proposed minutes, or summary minutes must be distributed to any member of the association upon request. Associations may charge for copying costs. Failure to provide minutes can result in penalties against the association. (Civ. Code §5235.)

**Unauthorized Publication.** Without board authorization, management companies do not have a "right" to publish draft minutes. As managing agents, they take their direction from the board. If the board instructs them, for whatever reason, to hold on the publication of draft minutes, the management company does not have a right to ignore the board's direction. The board must make minutes available in draft form for review by the membership within 30 days of the meeting. If there is concern about publishing draft minutes that may contain errors, boards should have the minutes sent to them for review and feedback to the minute-taker for corrections before they are posted.

**DRAFT Minutes.** As noted above, there is no requirement that draft minutes be posted. There is, however, a requirement that they be distributed to members who request it. If and when draft minutes are posted or distributed, they should have a large "DRAFT" stamp on the page or marked "DRAFT only— not approved by the Board" or something similar to indicate the minutes have not yet been approved by the board and may contain errors.

**Publish Approved Minutes.** Once draft minutes have been approved by the board, they should be distributed to the membership in some fashion— either by summarizing them for the newsletter, posting them on a common area bulletin board, posting them in a password protected place on the association's website, and/or mailing them to the membership. Approved minutes must be permanently available for inspection by the membership.

What Should Not Be in the Minutes. Minutes should not contain owner comments and never be a transcript of every statement made by directors and attendees. Recording every comment creates potential defamation claims or becomes evidence for other claims against the board and the association. Minutes should reflect decisions and reasons for those decisions, not conversations. "The minutes should never reflect the secretary's opinion, favorable or otherwise, on anything said or done." (Robert's Rules, 11th ed., p. 468.)

**What to Include.** As a rule, minutes should record what was done at a meeting, not what was said. (Robert's Rules, 11th ed., p. 468.) Even so, the motion should include the rationale for the board's action. Following is a list of essential information that should be found in every set of minutes:

- 1. Name of the Association.
- 2. Type of Meeting. Regular, special, emergency, executive session.
- 3. Date/Time/Location. Date, time and location of meeting.
- 4. Attendees. Directors who were present and who was absent, along with their titles (President, Treasurer, etc.). The minutes should also list guests who were invited to speak to the board, such as the association's CPA, contractors bidding on projects, the association's attorney, etc. Persons who attend the meeting need not be listed in the minutes. (If their names are included in the minutes, they could be subpoenaed for a deposition in the event there is litigation surrounding the meeting.) Instead of attendee names, some associations list the total number of attendees at the meeting. This is not required but is optional.
- 5. Approval of Minutes. Prior meeting minutes should be read and approved. (Robert's Rules, 11th ed., p. 473-474.)
- 6. Treasurer's Report. A verbal report is sufficient.
- 7. Committee Reports. The fact that an officer and committee report, if any, was given. When a committee report is of great importance it can be entered in full in the minutes. (Robert's Rules, 11th ed., p. 471.)
- 8. Guest Speakers. "The name and subject of a guest speaker can be given, but no effort should be made to summarize his remarks. (Robert's Rules, 11th ed., p. 471.)
- 9. Motions. Motions and how directors voted.
- 10. Executive Session. General description of matters discussed in executive session.
- 11. Next Meeting. Date of the next meeting.


