Vicki Barnes, our MCIC playground expert, is ecstatic at the completion of the Genoa Multi-challenge Playscape upgrade. On November 13, 2019 the new equipment passed final state inspection, the caution fencing came down and the fun began. Beth Williams, scissors in hand, surrounded by her friends Luke McNamara and Lila Sanita, were given the honors of officially opening the playground up for a new level of challenge and fun with a ribbon cutting ceremony!

Luke McNamara is so excited about what he refers to as the new teeter totter (now the Jump 2 It) and he could not wait to demonstrate for me. As he went up and down, he yelled out, "this is so much more fun than the old teeter totter!" His Mom, Kylie McNamara, shared that he has done nothing but talk about how much fun it is saying, "Please let's go back to the park and teeter totter!"



Vicki Barnes reports that the prior large unit designated for ages 5 to 12 was installed in 1999. Due to extreme rust, pipe disintegration and the teeter totter not complying with current safety codes, replacement was needed.

A sub-committee of MCIC made up of island parents worked with the playground company to design a new playground that replaced every play mode from the prior structure. They were also able to add six new pieces of equipment while adhering to all the state mandated Safe Space Zones standards.

The new equipment is designed for the 5 to 12 age range (as was the prior equipment). The Multi-Challenge Playscape brings a new level of experience that encourages continual multi range movement. This will provide hours of fun for our children. Beige slides which retain less heat were ordered and unfortunately blue were shipped. All 3 blue slides will be replaced by the factory at no cost to LICA. Anticipating the energy level and the need to stay hydrated, a new drinking fountain will also be installed.



All ages will enjoy the new equipment, while smaller children may need adult supervision until they too master the challenge.

San Remo Playground, coming in the Spring of 2020, is designed for the 2-5 age range- a TotMax Playscape with shade cover. Both playgrounds are Consumer Product Safety Commission and IPEMA approved.

Evacuating? Don't forget the 6 P's of Packing

In the past year, disasters (wildfires, extreme storms and flooding, threats of tsunamis and strong aftershocks, air and water contamination) have prompted voluntary and mandatory evacuations.

Imagine that you are ordered to quickly evacuate your home on Lido or perhaps a second home in the mountains or desert or even a hotel on an exotic vacation. What would you pack? The best time to consider this question is not when the order comes but NOW. Kate Hutton, at LA's Emergency Management Department, suggests six categories of things to pack. They're called the 6 P's.

1. People and Pets. Your family members — human and otherwise — should be your first priority when you evacuate. If you have a pet, bring what it will need on the road and in a shelter -- food, water, bowls, medication, leash, crate, toys and proof of updated vaccinations.

2. Papers and Phone numbers. Bring passports, birth certificates, your marriage license, property documents and proof of medical insurance etc. as well important phone numbers. Rather than carrying hard copies, it's more practical to store photos of these on a memory stick or in 'the cloud'.

3. Prescriptions. Pack prescription and OTC medication as well as eyeglasses, contact lenses and solution. A first aid kit is a must. And remember your toothbrushes and toothpaste. For babies and toddlers, you'll need diapers, wipes, a stroller and comfort toys.

4. Pictures and Personal items. Discuss beforehand what each family member would take if they ever need to evacuate. If possible, have these in an accessible location. The time to choose and search for these items is NOT when you receive the order to evacuate.

5. Personal computers/smart Phones are essential for accessing critical information and staying in contact. Don't forget extra batteries and the correct chargers.

6. Plastics. Bring your ID, insurance, credit and debit cards. You'll also need cash in case ATM's aren't working.

And on the way out the door, don't forget your always-packed grab-and-go bag. But that's a topic of another article.

I'm writing this column with Thanksgiving just around the corner. Thank you to everyone on our Lido Response Team and especially to Bob Chambers. It's Bob who year-in and year-out has kept our shed packed-full and response-ready. Honestly, it would never occur to me, for example, that the oil in the generators and the water in our 55 gallon container need to be emptied and changed on schedule. Bob, thank you from all of us!

I cup Crisco

3 eggs, beaten

I teaspoon salt

Jumbles

2 cups sugar

- I cup sour cream 4 cups flour
- I heaping teaspoon each cinnamon, allspice and nutmeg
- I small rounded teaspoon baking soda 2 tablespoons sugar and I teaspoon cinnamon (for topping)

Cream sugar and Crisco. Add sour cream and eggs. Sift together flour, spices, baking soda and salt. Add to above. Spoon into greased muffin cups and sprinkle with the mixture of cinnamon and sugar. Bake in 350-degree oven for 15 to 20 minutes, until cake tester comes out clean. Serve with peaches and brandy, and/or ice cream, heavy cream, etc.





Holiday Safety Tips

The holiday season is here. During this special time of year, I would like to provide security tips from the Newport Beach Police Department and a few of my own.

I. Shopping Reminders

- Pay attention. Implement your situational awareness at all times.
- Notify loved ones where you will be.
- Make sure your cell phone is fully charged before you head out for the day.
- Have small children shopping with you? Develop a plan/safety protocol to stick together and what to do if you get separated.
- Never leave valuables unattended (phone, purse, wallet, etc.).
- Use a purse with a zipper and keep it zipped closed.
- Do not hang your purse over the back of your chair.
- Have your key in your hand when approaching your vehicle. Check the back seat and around the vehicle before getting in.
- Do not leave packages visible in your vehicles windows.
 Stow them in the trunk, underneath the SUV cargo cover, or if possible, take them directly home.
- Do not park your vehicle outside your garage or on the street, with shopping bags left inside.

2. Package Theft Suggestions

- Use of doorbell cameras.
- Never leave a note telling the delivery person you are not home.
- Not home to receive the delivery? Have packages sent to your office or to the home of a friend, neighbor or family member.
- Use local pickup options: in store locations, post office, Amazon lockers, etc.

3. Residential Burglaries

- Avoid displaying gifts and other valuables in places easily seen from windows and doors.
- Always keep porch lights on from dusk to dawn, using photo cells/ timers or manually.
- Always lock all doors and windows whenever you leave your home. If you have an alarm, remember to set it.
- Implement security cameras/doorbell cameras.
- Use timers to turn on/off radios and interior lights. Maybe turn on your TV. Give the appearance that someone is home.
- Do not advertise if you are going out of town. That includes posting images on social media.

Always remember to report suspicious activity to the N.B.P.D. nonemergency number at 949.644.3717. Obviously, if it is an emergency situation, call 911.

Finally, I would like to part with this suggestion. There are many that struggle at this time of year for several reasons. If you are aware of someone that fits this profile, be kind and offer help. Even if it is to have a simple conversation. Kind gestures go a long way. Have a wonderful holiday season, happy new year and be safe.







Homeowners Forum

1. City Staff will draft the revised code language.

- 2. The code language is presented to the Planning Commission for a recommendation.
- 3. The recommendation is then presented to the City Council for approval or denial
- 4. If approved by the City Council, then it goes to the California Coastal Commission (CCC) for a hearing

5. If approved by the CCC it comes back to our City Council for final approval. This may look like a long process, and unfortunately it is.

This process will take a minimum of 18 months to complete, assuming that everyone approves the code change. In the meantime the City's hedge height limit continues to be 42 inches.
