# Self Defense Class Was a Huge Hit!

Future classes will be scheduled in the next few months

After a three-year absence for several reasons, the clubhouse was host to another LICA Self-Defense Class, conducted on Thursday, March 2, 2023. For those that are new to Lido Isle or are unaware, this course is free to all Lido Isle residents. My way of giving back to the community and helping neighbors become a little more prepared when they start out their day.

I have taught several of these courses since 2014 and have always tried to improve the class. Turnout has always been positive over the years but this class was the largest. There were 43 people who expressed interest in attending and 27 showed up. That is a large class and fortunately I had my son available to assist. I was pleased to see the turnout and enthusiasm of all that wanted to learn and practice certain techniques. The scenarios-drills that seemed to garnish the most attention are the following: situational awareness, use of space-distance, forms of communication, and vehicle tactics. Yes, there was a core group willing to beat up 'Bob the Dummy,' and I always enjoy that part.



Provided to each resident who attended was a class syllabus. This outline can provide the proper foundation for one to train with, and when done correctly, can help you avoid a confrontation, and or work your way out of a difficult situation. The syllabus is backed up by my 30 years of various, effective martial

arts, 13 years conducting executive protection details, use of and encountering tools-weapons, communication, mindset, movement, situational awareness and vehicle scenarios. The class was structured on a basic, introductory level, but as I mentioned to the attendees, you can take the information and go as vertical as you wish (all the way up to an expert level). Of course that requires years of training with the proper instructors.



The one problem with the course is the time. There is guite a bit of information provided. The class usually lasts 1.5 hours. At that point, most everyone is ready to go home. Several ladies did stay longer with very good questions and inquired about the grappling portion of the syllabus. So, I have decided for future self-defense classes, we will focus on 2-3 techniques from the syllabus. Residents can attend a particular class of interest or all of them, which will cover the entire course outline. Stay tuned over the next several months for another class.



Thanks again to all that expressed interest and especially those who took a busy part of their day to train, and be a little more prepared for the 'what if' scenarios. Until the next class, stay safe and have a great day.



At this time, the drafts have been forwarded to the Association's legal counsel for review. Upon review, the Board will mail the proposed changes to homeowners for a 28-day commentary period.

- Project information signs are required to be posted.

- Landscape watering by automatic timers must be 10 minutes or less per sprinkler.

- Water leaks or malfunctions must be fixed within three days.

Will you help fill in the gaps? -

The LICA CERT has lost volunteers due to natural attrition and lack of activity during the pandemic. At one point the program was so strong that it received awards from the city. It now needs volunteers, especially block captains. Ideally each block would have a volunteer captain who would communicate with the residents of their block to understand injuries, damage and situations such as fire, gas leaks, etc. that could lead to loss of life or more injuries. Under the CERT program, organized and operated with assistance by the City of Newport Beach, the information from the block captains would be communicated to the Newport Beach Fire Department that would then make the decision on allocation of resources to save the most lives. With high density areas like apartments and high rise office buildings in the city, Lido may not see much assistance, so the island needs to be as independent as possible using organized, trained and educated teams of resident volunteers. CERT is also looking for volunteers to assist with other duties at the San Remo park CERT staging area. Setup and take-down of tables and equipment,

The Community Emergency Response Team "CERT" educates residents in disaster preparedness for hazards that may impact our community and trains them in basic disaster response skills such as fire safety, light search and rescue, team organization, and disaster medical operations. Using the training learned in the classroom and during exercises, CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help.

CERT programs started in Los Angeles, California and spread across the United States and abroad. Officials from Los Angeles traveled to

Block captains are the backbone of the CERT program as they work to provide the Fire department with the information they need to assist residents. Currently, Lido CERT is in need of more than 35 block captains to fill the voids in this table:

CERT recognizes that some residents travel and vacation schedules may limit their ability to serve as block captains, so it is encouraging coJapan in February of 1985 to study its disaster response plans. The team discovered that Japan had extensive neighborhood-based training programs focused on fire suppression, light search and rescue operations, first aid, or evacuation.

Following the 1987 Whittier Narrows earthquake, Los Angeles created the Disaster Preparedness Unit within the Fire Department. Their goals were to:

- Educate and train the public and government sectors in disaster preparedness
- Research, evaluate, and disseminate disaster information
- Develop, train, and maintain a network of Community

Emergency Response Teams (CERTs).

In 1993, The Federal Emergency Management Agency (FEMA) decided to make the concept and program available to communities nationwide. The Emergency Management Institute (EMI), in cooperation with the LAFD, expanded the CERT materials to make them applicable to all hazards.

CERT plans to sponsor first aid classes and other programs to help families understand and prepare for disasters and emergencies. CERT will also sponsor education on a variety of preparedness subjects including detection of natural gas leaks and when and how to turn off gas in an emergency, preparing "go bags" to grab in the event of an emergency, backup power sources, etc.

Lido's Community Emergency Response Team "CERT" educates residents in disaster preparedness for hazards that may impact our community and trains them in basic disaster response skills such as fire safety, light search and rescue, team organization, and disaster medical operations. Using the training from courses held at the fire department and sponsored by FEMA, CERT members can assist others in their neighborhood or workplace following an event when professional

captains - block captains that "share" a block area. Some block areas could be shared by two co-captains; when one co-captain is traveling or on vacation, the other could be available. Co-captains would notify their co-captain of such plans so that they could serve as block captain in the event of a disaster. If a volunteer does not travel or vacation more than a few weeks a year then they might want to be a block captain without a co-captain. Either way, block captains or co-captains are essential for the proper functioning of the island's CERT program.

#### responders are not immediately available to help.

While CERT volunteers are there to help, their first duty is naturally to their families. It is important to understand that CERT's supplies are limited to medical equipment such as bandages, gauze, splints, etc. The program does not have food or water for residents, so they should have their own supplies in the event of need. Based on FEMA comments, CERT expects that in the event of loss of water supply, the government would respond within three days, so families should have at least a three day water and food supply. The LICA office has checklists available to residents to help them prepare for emergencies and CERT suggests that you ask for a copy and review it with your family in mind.

Johnny Mercer, who lived at 108 Via Koron. If you are interested in getting more information about Johnny, or music in general, Old Isle would suggest checking out the Johnny Mercer Foundation website: johnnymercerfoundation.org. It is a wealth of information on Johnny's music and includes access to extensive Spotify playlists which are an incredible compendium of Johnny's musical works. Just click on the "Initiatives" button at the top of the website, and it will lead you to resources such as videos (Vala virtual learning program) and written materials that allow students to discover more about the history of musicals, Broadway and Johnny himself. These are all part of the foundation's "Accentuate the Positive" program. It's really well done and could be a fun family project.

## Lido Isle... a "pleasure ground for the elite"! The Tashman/Lowe Story...

Old Isle found an interesting article in the Los Angeles Times, dated July 10, 1930, about the establishment of a Lido Isle "film colony". Lido was cited as a "pleasure ground for the elite" where the stars were offered "seclusion from the public". The included list of Hollywood luminaries establishing themselves on Lido Isle at the time were Joseph M. Schenck, Louise Dresser, Jack Gardner, Al Rockett, Richard Dix, Warner Baxter, Harold B. Franklin, Mrs. H.C. Witwer, James and Lucille Gleason, Edmund Lowe and Lilyan Tashman, Robert M. Yost, Jr., Victor Fleming, David Butler, Alfred Cohn and Hayden Talbot. It's an extensive list although many of their names have perhaps not lived through the ages.

of society at the time such as Cecil Beaton, Mary Pickford and Fanny Brice. More than 10,000 fans came to her burial in Brooklyn's Washington Cemetery (and there was a nearriot at the gravesite, apparently).



The Tashman/Lowe story is an interesting one, however. Both successful actors of their time, they married in 1925. They had several homes including Lilowe in Beverly Hills (718 N. Linden) and a home in Malibu. Their lives were heavily scrutinized. Tashman's million-dollar wardrobe and the fact that her cats were served daily afternoon tea by her staff were subjects covered by the contemporary Hollywood press. There was a sad ending to the story in that Tashman was admitted to a New York hospital in 1934 for an appendectomy (likely serving as a cover story for an actual case of abdominal cancer) and died shortly thereafter at the age of 37. Her funeral was attended by the crème de la crème

Old Isle cannot find any substantiation for Tashman and Lowe actually having

built a house on Lido Isle. We can say that Lilyan was photographed with Harold Grieve, the designer of Lido's clubhouse, in the the late 1920s, so there is some sort of connection. But perhaps, with Lilyan's untimely death, the Lido plans never came to fruition. It is fun, however, to peruse the online photos and descriptions of Lilyan's life, as she lived with a style and vigor that certainly would have gone done in Lido Isle history!

## trawberry Cobbler from Pioneer Woman Baked right in the skillet! Ingredients: 1 stick salted butter (1/2 cup) 11/4 c. granulated sugar, divided 1 c. self -rising flour 1 c. whole milk 2 tbsp. cornstarch 2lb.strawberries, halved

(about 61/2 cups) 1 tbsp. fresh lemon juice Vanilla ice cream, for serving

## Directions:

Preheat the oven to  $350^\circ$ . Add the butter to a 10 -inch cast iron skillet; place in the oven for 5 minutes or until the butter is completely melted, swirling the pan occasionally. Remove from the oven and set aside. Whisk together 1 cup of the sugar with the flour and milk in a medium bowl. Whisk together the remaining 1/4 cup of sugar and the cornstarch in another medium bowl. Add the strawberries and lemon juice to the cornstarch mixture, stirring to combine. Pour the batter into the melted butter in the cast iron skillet. Do not stir! Spoon the strawberry mixture and any juices left in the bowl evenly over the batter, without stirring. Place the skillet on a foil-lined baking sheet and bake on the middle oven rack until golden brown and bubbly, 60 to 75 minutes. Let cool on a wire rack at least 15 minutes before serving with vanilla ice cream, if you like.


