Do I really need a FIRE EXTINGUISHER?

The most important parts of a fire safety plan are, by far, smoke alarms and an evacuation plan. Should you also buy one or more fire extinguishers? Yes, but only if you know when and how to use them. With proper training and education, fire extinguishers can save lives and property by putting out a small fire or suppressing it until the fire department arrives. Here are some things you should know when choosing, maintaining and using fire extinguishers.

Choosing and Maintaining Fire Extinguishers

For the home, select a multi-purpose extinguisher that can be used on all types of home fires.

Choose one that is large enough to put out a small fire but not too heavy to handle.

The fire extinguisher should have the label of an independent testing laboratory.

Some extinguishers need to be shaken monthly, others need to be pressure-tested every few years. It's helpful if the extinguisher has a gauge that shows if the pressure is too high or too low.

Make sure that the can, hoses and nozzles aren't damaged, dented, or rusted.

Remove any dust, oil, or grease that might be on the outside of the extinguisher.

Read the instructions that come with the fire extinguisher and become familiar with its parts and operation before a fire breaks out.

Fire extinguishers should be stored close to an exit. Be sure nothing is blocking or limiting your ability to reach it.

Most extinguishers have a gauge to show the charge state, which should be in the green. Checking twice a year is ideal, perhaps on daylight savings dates.

Using Fire Extinguishers

Local fire departments or fire equipment distributors often offer hands-on fire extinguisher trainings.

Use a portable fire extinguisher when

- the fire is confined to a small area, such as a wastebasket, and is not growing,
- everyone has exited the building,
- the fire department has been called or is being called,
- the room is not filled with smoke.

To operate a fire extinguisher, remember the word **PASS**:

 Pull the pin. Hold the extinguisher with the nozzle pointing away from you, and release the locking mechanism.

- Aim low. Point the extinguisher at the base of the fire.
- Squeeze the lever slowly and evenly.
- Sweep the nozzle from side-to-side.

SCAN with phone camera

Keep your back to a clear exit when you use the device so you can make an easy escape if the fire cannot be controlled. If the room fills with smoke, leave immediately.

Only adults who know how to operate portable fire extinguishers should use them. Children should not be trained to use a fire extinguisher. They should be taught to get out and stay out if there's a fire.

Whether or not you have a fire extinguisher, remember that because fires grow and spread rapidly,

the #1 priority for residents is to get out safely. For this reason, no household should be without working smoke alarms and a fire escape plan.

Use the ΩR code in this article for a 4 minute video from a California fire department that will explain the basics of fire extinguishers.

Will you be a Block Captain?

CERT continues to recruit block captains for the island program. Great progress has been made in contacting all existing block captains from last year and confirming those are still available and adding new block captains on many streets.

Block captains are the backbone of the CERT program as they work to provide the Fire department with the information they need to assist residents. Currently, Lido CERT is in need of approximately 40 block captains to fill the highlighted voids in the table below:

CERT recognizes that residents' travel and vacation schedules may limit their ability to serve as block captains, so it encourages co-captains - block captains that "share" a block area. Some block areas could be shared by two co-captains; when one co-captain is traveling or on vacation, the other could be available. Co-captains would notify their co-captain of such plans so that they could serve

PICKLEBALL on lido

3 MONTH TRIAL PERIOD FOR INTERIM RULES JULY 15-OCTOBER 15


In response to community input and to help improve court-time accessibility for Lido's pickleball enthusiasts, the LICA Board approved a 3-month trial period, effective July 15, to better manage the online pickleball reservation process and clarify rules for court use. As always, LICA encourages input and feedback from residents. Please contact the LICA management office if you have questions or comments.

The following policies are exclusively for the Jucar Pickleball/ Basketball court for a 3-month trial Period from July 15, 2023 through October 15, 2023

- 1. Continue to limit all pickleball play on Lido to the current Jucar pickleball/basketball court unless otherwise approved by LICA.
- 2. Adjust existing reservation website to charge \$2/half-hour, \$4/hour, \$6/1.5 hours to reserve the Jucar pickleball/basketball court. Note: This is the same amount that LICA currently charges to reserve the Jucar, Barcelona and San Remo tennis courts.
- 3. Prohibit back-to-back reservations over 90 minutes.
- 4. Limit reservation/play time for both pickleball and basketball to 8am 6pm. Play may not begin before 8am and must conclude by 6pm.
- 5. Allow reservations to be made up to one week in advance.
- 6. Limit reservation/play time to a maximum of 90 minutes per day per person and a maximum of one reservation per household (Lido Isle address) per day. Non-compliance could result in revocation of court privileges and/or fine.
- 7. Require an online reservation for all court play (pickleball and basketball) at the Jucar court, including same-day walk-ons. Reservations can be made on desk-top computers and mobile devices.
- 8. Monitor reservation "no-shows." Serial reservation "no-shows" may be subject to loss of court privileges.
- 9. Adjust online reservation system to track reservations and court use by Lido Isle address, resident name(s) and guest name(s) if resident is hosting an offisland guest.
- 10. Continue to prohibit amplified music, alcohol, parties, pets, bikes, skateboards, scooters.
- 11. Encourage use of noise dampening soft balls and paddles for pickleball play.
- 12. Include reminders about court rules in reservation confirmation email.

Additionally, staff is directed to initiate the following and bring back to the LICA Board for review and approval.


- Obtain quotes for noise screens, a quality rolling net and seating for up to four people at Jucar pickleball court.
- Identify alternative online reservation system if the current system cannot accommodate requested parameters.



We regret to report that there have been several recent instances of vandalism at Lido's tennis facilities including pet feces, human urine (no kidding, caught on camera), difficult to remove curse words and lurid drawings written in "dust graffiti" on the wind screens, and damaging bike and scooter tire marks. Facility gates are also being inappropriately propped and left open, and the Barcelona, Jucar and San Remo tennis courts are being marked, taped and used for pickleball, which is prohibited. Pickleball is only permitted on the designated Jucar pickleball/basketball court.

Lido's beautiful recreational facilities are owned by and meant for the enjoyment of all Lido residents. It is imperative that we all treat them with care and abide by LICA rules of use. If you witness abuse of the facilities or see something that needs to be cleaned or repaired, please report it to LICA Management. All LICA facilities are monitored by video cameras but we also appreciate your assistance in keeping them clean and in tip-top condition.




LEAF BLOWERS

Make sure it is electric, not gas powered!

To protect residents from nuisance and excessive levels of noise, and to promote comfort, safety, and welfare, the City of Newport Beach adopted an ordinance **prohibiting** the operation of **gas-powered leaf blowers** in residential neighborhoods. This ordinance does not prohibit electric leaf blowers and is enforced by the city, not LICA. To file a complaint or report a person acting in violation of the Gas-Powered Leaf Blower Ordinance, call Newport Beach Code Enforcement at (949) 644-3215.






Kaye Sharbrough CO-VICE PRESIDENT PROGRAMS

- **E.** Wet Storage Space 623 Via Lido Nord Resolution: A motion was made, seconded, and unanimously carried to extend existing leasing terms for both wet and dry storage spaces until December 31, 2023. Owners must vacate the wet and dry boat storage spaces no later than December 31, 2023.
- F. Insurance D&O Coverage Increase No action as taken at this time.
- **G.** Pickleball Sub-Committee Update Resolution: A motion was made, seconded, and unanimously carried to approve the following recommendations are exclusively for the Jucar Pickleball/Basketball court

Effective July 15, 2023

- a. Adjust existing reservation website to charge \$2/half-hour, \$4/hour, \$6/1.5 hours to reserve the Jucar pickleball/basketball court. (This is the same amount that LICA currently charges to reserve the Jucar, Barcelona and San Remo tennis courts.)
- b. Note: Back-to-back reservations over 90 minutes at this court are currently not allowed per Directive 25, due to high court use demand, as authorized by the Board at their meeting on May 10, 2023.
- c. Direct staff to get a quote for a quality rolling net to replace existing net donated by residents and seating (bench or chairs). Check into an alternative online reservation system if the current system cannot accommodate parameters listed below.
- d. Direct staff to get quotes for noise screens for PB/BB and practice courts. Bring estimates back to the full board for consideration.

For a 3-month trial Period from July 15, 2023 through October 15, 2023

- a. Continue to limit all pickleball play on Lido to the current Jucar court unless otherwise approved by LICA.
- b. Limit reservation/play time for both pickleball and basketball to 8am 6pm (play must conclude by 6pm).
- c. Allow reservations to be made up to one week in advance.
- d. Limit reservation/play time to a maximum of 90 minutes per day per person and a maximum of one reservation per household per day. Non-compliance could result in revocation of court privileges. (Need to define trigger and time period for loss of privileges).
- e. Require online reservation for all court play (pickleball and basketball) at the Jucar court, including same-day walk-ons.
- f. Serial reservation no-shows may be subject to loss of court privileges.
- g. Adjust online reservation system to require/track reservations and court use by address, resident name(s) and guest name(s) if resident is hosting an off-island guest.
- h. Prohibit music and alcohol.
- i. Encourage use of noise dampening soft balls and paddles.
- j. Include reminders about court rules in reservation confirmation email play-time limits, no-show policy, no music, no alcohol, no parties, no pets, no bikes, no skateboards, no scooters, etc. Court is monitored by camera and security. Be good neighbors.
- **H. Sailing Program and Approval of Legal Agreement** The Board has directed the subcommittee to meet with the Yacht Club and finalize the legal agreement.

Resolution: A motion was made, seconded, and unanimously carried to approve the current sailing program to follow proper background check protocols per law and allow up to 25 guest participants who are not lido residents.

INGREDIENTS

1/2 C unsalted butter, 3/4 C packed brown sugar, 1 large egg, 1 tsp vanilla extract, 1 C all-purpose flour, 1 C graham cracker crumbs (about 8 full-sheet graham crackers), 1/2 tsp baking powder, 1/4 tsp salt, 1 C semi-sweet chocolate chips, 1 C marshmallow crème.

PREPARATION

Bake at 350°. Line 9-inch square pan with parchment paper, leaving overhang for easy removal. In large bowl of stand mixer, cream butter and brown sugar together for 2 minutes. Add egg and vanilla extract, beat until combined - mixture may appear curdled. In separate bowl, whisk flour, graham cracker crumbs, baking powder, and salt together. Pour flour mixture into wet ingredients, beat at medium speed until combined. Next, press 2/3 of dough into prepared pan then spread the marshmallow creme evenly on top. Layer chocolate chips evenly on top. Mold the remaining cookie dough into flat pieces and layer on top of the chocolate chips. There will be gaps! Bake for 25-30 minutes, until top is golden brown. Cool completely before removing from pan. Cut into squares. Cover and store leftover bars at room temperature for up to 1 week.


