Twenty-seven years ago on Thursday, December 5th, 1997, the newly designed and planted Genoa Circle had its first holiday tree/park lighting event. The lights and decorations were supplied by the neighbor Hap Byers, and the set up was done by the Lido Isle Men's Club.

Coincidentally, this year's event was also held on Thursday, December 5th; but the display, activities, and crowd were much more grand than the first time.

More than 150 people came out to see Santa arrive with the Newport Beach Fire Department. Hot chocolate and cookies were served; a craft table was available for ornament making. Christmas music was provided by DJ DeVille who got some of the crowd dancing.

LICA Director Ronda Clark welcomed the crowd; Men's Club Rep John Oyler introduced Santa as he stepped off the fire engine. Santa had the crowd help with a count-down which magically lit the tree and the surrounding park.

Lit by more than 6,500 sparkling lights, the tree reaches twenty feet in height and is adorned with over five hundred ornaments. The Park will remain lit during the holiday 🗢 📈 season until January 2, 2025.

Marine Facilities: Maintenance Plans for 2025

Preparations for Summer Sailing & More

Lido Marina Facilities


As everyone knows, Lido's marina facilities are very vital to our community. It is extremely important that we keep them up and maintain each of these various marinas to a high standard. The following programs are being implemented in the next 12 months.

Antibes

LICA is looking into constructing a 2-3-foot garden wall along the bank of the dry storage/trailer area that will reduce or eliminate water and mud runoff from the landscaping area behind the boats, therefore, keeping this area clean from debris. A contractor proposal to build this structure will be presented to the LICA Board in early 2025 for review and approval.

LICA will also look at restriping the Antibes storage area to make it more user friendly and efficient. Additionally, the board is reviewing LICA's Boat Storage Lease Agreement form and Directive 11, which provides rules and requirements for all boat storage on LICA facilities including wet slips, side ties, moorings and dry storage. Both the lease form and Directive 11 are antiguated documents and need to be revised to present standards.

Finally, a portion of the seawall at Antibes is failing and needs to be shored up. LICA is currently working with the City to determine the best engineering solution.



There have been ongoing complaints of non-residents using LICA's private docks and marine facilities. Only LICA residents or authorized guests of Lido residents may use the docks subject to the rules and limits outlined in LICA Directive 9: Rules for the Temporary use of LICA Docking and Marine Facilities.

Harbor Patrol is the enforcing agency for all Harbor related issues. Please note when it concerns LICA owned facilities such as docks, Harbor Patrol will only respond to calls from LICA Management or LICA Security. To report unauthorized use of LICA docks or marine facilities to Harbor Patrol individuals must first notify LICA Management (during office hours) or LICA onsite Security (during non-office hours). They will then contact Harbor Patrol with your report.

Directive 9: Rules for the Temporary use of LICA Docking and Marine Facilities may be viewed on the LICA Portal at LidoIsle.org or by requesting a copy from the onsite LICA Management Office.

How to Report Unauthorized Use of LICA Docks or Marine Facilities:

- During LICA Office Hours/Monday through Saturday, 8 am to 5pm: Call the LICA Management Office at (949) 673-6170. Staff will then call Harbor Patrol.
- After Office Hours, Holidays and Sundays: Call LICA Security by CitiGuard at (949) 991-8473. The on-duty Patrol Officer will then call Harbor Patrol.

Directive 3 & Directive 7 Approved

After a mandatory 28 day review and comment period, updates to Directive 3: Rules for Clubhouse Use, and Directive 7: Street End Parks, was approved as proposed at the December 11, 2024 LICA Board meeting. Copies of the revised directives can be viewed at Lidolsle.org on the LICA Portal or at the onsite LICA Management Office during regular office hours.

LICA has signed a refurbishing agreement with a contractor that will be installing new rub rails on the dock, painting the ramp railing and power washing the facility.

Happy new year to all, and while Old Isle takes a little new year's break, this month's column will be a slightly edited "oldie but goodie" article from May 2018. Take this chance to get to know these luminaries who took a hand in developing not only Lido Isle, but the whole LA area. Their names make for some fun googling.

They Made Lido Isle...redux

Readers of this column may remember that this is almost the 97th anniversary of the founding of our lovely island. In July of 1928, there were a series of "opening days" celebrating the amazing new development of Lido Isle, and people from all corners of southern California attended. In fact, Lido's developers were rather overwhelmed by the response, and sources of the time state that people needed to give an RSVP to make sure that they would have a place at the celebration, as this was pre-bridge, so all transport to the festivities was by launch. Apparently 2000 people were left standing at the dock. The reason for the popularity of this event was possibly that some of the leading design and architectural lights of the time were involved in the

McAfee (1888-1960, architect and MGM production designer for many movies, including "Singin' in the Rain"); Franz Herding (1887-1968, Swiss-born architect of La Quinta, Leimert Park and Chevy Chase Estates in Glendale); and Stiles O. Clements (1883-1966, architect of the Wiltern and El Capitan theatres, Citadel Outlet Mall -which originally was an Assyrian-style tire company). These men were cutting edge and on top of their game. Old



movie art director) Harold Grieve (1901-1993) who was known to be "startlingly modern". He designed the interior of the Clubhouse with custom furnishings. The other people in the photo are "to be determined", and Old Isle welcomes any input on this! Old Isle loves that this very eclectic group is standing in front of a Chinese gate that used to be the street-side centerpiece of Lido's Moorishstyle clubhouse (and our Clubhouse is still in this structure, although largely bereft of original architectural details). The imagination and worldly view that was part of Lido Isle's origins still helps make the island a special place today.

Repersence Parade Pancakes It is truly a uniquely Southern California New Teal's monning tradition, but who doesn't love rolling out of bed in your PJs and slippers to turn on the TV and watch the Rose Parade? And while you're at it, please enjoy these light as a feather, made from scratch pancakes with homemade Cinnamon Syrup.

1 egg, beaten, 1 cup milk, 2 Tablespoons vegetable oil, 1 cup all purpose flour, sifted, 1/2 teaspoon salt, 2 Tablespoons baking powder, 2 Tablespoons sugar

Combine egg, milk and oil. Add dry ingredients and beat until smooth. Batter should be thick. Heat griddle. Brush griddle lightly with oil. Spoon about 1/4 cup of batter, per pancake, onto griddle. Cook until top of pancake is set and flip. Cook until golden brown.

Ingredients: 1 cup sugar, 1/2 cup light corn syrup, 1/4 cup water, 3/4 teaspoon cinnamon, 1/2 cup evaporated milk.

Directions: Combine sugar, syrup, water and cinnamon in a saucepan. Bring to a boil and cook 2 minutes, stirring constantly. Cool 15 minutes and add evaporated milk. Junior Staff Commodore Russ Butcher proudly swore in all newly elected Flag Officers, marking the official start of a new year for LIYC.


LIYC extends its gratitude to all members and to all the volunteers who contributed to the club's success.

Other points to remember include the usual announcements and Yours Truly with a list of personalized LIMC Trivia such as: Which LIMC member has lived on Lido the longest, in fact his entire life? If you don't know the answer to that one, then are you really a true Lido person?

The not-so-fun part was forking over \$450 for the annual dues for 2025. But when you think of all you get it's worth it. I do recommend that everyone bring their own wine glass to the Mag Monday dinners unless you really do like drinking wine from a little plastic cup. Fortunately, when Kora caters, she provides them.






