# LANDSCAPE **MASTERPLAN Project Update**



LICA Board Director

- Summers/Murphy & Partners Hired
- Preliminary Design Concepts Close to Completion
- Phase I Expected to Begin in 2025

Your LICA Board has continued to focus on improving and upgrading the isle's common areas including the tennis facilities, marine facilities, landscape, clubhouse and ongoing maintenance issues. The following is an update regarding the status of the Landscape Masterplan project:

#### LICA LANDSCAPE MASTERPLAN

In the spring of 2024, the LICA Board initiated the process to develop a Landscape Masterplan. This Masterplan addresses critical areas of the isle such as the entry point, end parks/ greenspaces, medians and landscape surrounds at the community facilities. The comprehensive Masterplan will not only enhance the isle and resident experience but is necessary to address the upcoming change in State laws governing and limiting the use of real grass in non-park spaces by 2028.

The LICA Board tasked the Major Capital Improvement Committee (MCIC), made up of three Board members and community club appointed volunteers, to select a landscape architectural firm to develop the Landscape Masterplan. The committee selected Summers/Murphy & Partners (SMP) to develop the Lido Isle Landscape Masterplan, SMP is known for their creativity and innovation in the world of landscape planning, having earned accolades and recognition for their commitment to guality and sustainability. SMP recently completed similar projects at Big Canyon and Monarch Beach.

The development of the Landscape Masterplan has focused on the following:

- Provide a phased implementation plan, while also making accommodation for the spaces that may need interim upgrades or require immediate partial refurbishment.
- Create a cohesive plant palette throughout the isle which incorporates texture, color, and plant size to create a pleasing environment throughout the year and provide pleasurable perspectives from the street, park, median or entrance.
- Consider water wise garden practices and provide an economical maintenance plan.
- Waterfront greenspace/park design to maintain and enhance the community use as well as maintain the window to the bay.
- Addresses the aesthetics of the entrance gateway to Lido Isle.
- Create a standard signage program for the community.
- Establish a bike rack replacement design standard that compliments the amenities and landscape plan.

SMP has been preparing preliminary design concepts for review by the LICA committee. After several iterations over the past five (5) months SMP is close to completing preliminary plans. The next steps will be to review the scope for proposed implementation and preliminary cost estimating. When completed we will have a community forum to present the concepts for feedback, which is expected to occur late spring or early summer. The project implementation will be phased to accommodate fiscal constraints although it is expected that we will begin phase one of the project in 2025. This is an exciting project that will enhance the environment and experience for all residents.

## Know Your Rights and Responsibilities **Rules for Contractor Vehicles** and Parking per LICA Directive 6

In response to community concerns and nuisance complaints regarding contractor and construction vehicles on Lido Isle, the LICA Board of Directors amended Directive 6 on August 14,2024.

All homeowners who are repairing, remodeling or building a new home on Lido Isle must ensure that their contractors are aware of and in compliance with the Directive 6, specifically Section 5: Rules, Regulations and Guidelines as follows.

#### F. COMMUNITY IMPACT:

- 1. Working Hours/Noise: Shall always be in compliance with the City of Newport municipal code. For Lido Isle, this is typically Monday to Friday 7:00am to 6:00pm. Noise should be minimized during working hours and with respect for neighboring residents.
- 2. Parking: Vehicles shall be parked according to street signs, and with respect for neighbors and areas adjacent to Construction. Contractor's vehicle should not enter or park on Lido Isle before 7:00am and after 6:00pm, Monday to Friday, DON'T PARK/BLOCK DRIVEWAYS OR RED ZONES AND FIRE HYDRANTS.
- 3. Contractor Vehicles should have a dashboard sign clearly visible identifying the driver, his telephone number, the contractor telephone number and the project address.
- 4. Nuisance Complaints California Civil Code Section 3479 - The Board may send a violation notice to homeowners for nuisance violations. The Board may impose fines on the homeowners' account for failure to comply with the Association's governing documents.
- 5. Any illegal parking activities, or nuisance complaints will be reported to the City of Newport Beach.

Based on this Directive 6, please note that any contractor vehicles (cars/SUVs, pickups, trucks) may not be on Lido Isle until 7:00am or after 6:00pm. In addition, all vehicles should have a dashboard sign providing site & contact information to enable notification/resolution of issues regarding parking.

Thank you for your attention to minimizing the impact of construction on Lido Isle.

# Update on the **City/LICA 25-Year Lease**

As has been reported in recent Islander articles, the 25-year lease between the City and LICA for the Antibes Boat Yard, Genoa East and West Dry Storage areas and the island's End Parks was set to expire on April 14, 2025. The City has asked LICA to sign a one (1) year extension to April 14, 2026, to allow them more time to prepare a new draft lease. This does not mean that it will take another full-year to negotiate and execute a new 25-year lease, but provides additional time for negotiations. LICA has agreed to this one-year extension and signed the legal documents in mid-April to make it official. Your LICA Board will keep the community informed as lease negotiations move forward.

# Lido Isle Community Association **2025 Annual Meeting**

On April 12, 2025, the Lido Isle Community Association (LICA) held our annual meeting at the Clubhouse. The meeting was well attended, and we welcomed guests from the City of Newport Beach. Joe Stapleton, Mayor, gave a comprehensive update on the City, current issues and Council initiatives, with an active Q&A session immediately afterwards. The overall status in the City of Newport Beach is very positive with several programs having good success over the past three years and an excellent financial status.

Newport Beach Fire Chief Jeff Boyles updated us on the Fire and Lifeguard Departments with the excellent news that Newport Beach is now ranked in the top tier Class 1 for response times. We also learned that in Newport Beach, cardiac incidents are addressed with close coordination between the city's EMS teams and Hoag Hospital resulting in better positive outcomes than virtually all cities in the USA. The NB Fire Department also provided teams and supported the efforts with the recent Altadena and Palisades fires.

Joshua Vincelet, Acting Deputy Chief of Police, reported on the progress made by the NBPD with special emphasis on resident safety and security, road safety and theft prevention. He was pleased to report that there had been limited incidents on Lido Isle with many calls being related to construction traffic and parking issues. He provided updates on the Citywide systems of License Plate Recognition (LPR) and new drone remote technologies that enable proactive and faster responses to many situations resulting in improved outcomes

With the formal purposes of the Annual Meeting highlighted, President Fraser asked for a determination of Quorum from the Inspector of Election (Lynn Cololough). Lido Isle has 881 member residences in LICA so minimum quorum is 441 (50% plus 1 or more). The number of ballots received as of April 12, 2025, was only 381 so quorum for the 2025 Annual Meeting was not achieved. In anticipation of this possibility, the Association opted to take advantage of the California's new law, adopted in 2024, allowing a minimum of 20% of member votes to meet quorum upon a Second Adjourned Meeting. Accordingly, LICA's second adjourned meeting for 2025 is scheduled for Friday May 2, 2025 at 5:00 pm. Per state law, a general notice has been issued. A copy of the notice is also included in this

LICA Members present at the Clubhouse on Saturday, April 12 for the 2025 Annual Meeting of the Members enjoyed refreshments, remarks by the Mayor and Police and Fire Chiefs, conversation with the officials and with each other. Thank you to everyone who attended and who voted in the election.

The number of ballots received was insufficient to achieve quorum, so the formal business of the Meeting: electing four (4) Members to serve as Directors of the Board and to approve the Minutes of last year's Annual Meeting, could not be conducted. In fulfillment of remaining requirements of Civil Code § 5115(d)(2), the 2024 California law allowing reduction of quorum at a reconvened Meeting if the first attempt lacks quorum, the Members present duly adjourned the Annual Meeting to Friday, May 2, 2025 at 5:00 p.m. at the Clubhouse.

At the second Meeting 20% of the membership present or voting by proxy or secret ballot will satisfy the quorum requirements for the election of Directors, and the ballots will be counted if the 20% quorum is reached. More than 20% of the Members have already voted, so while Ballots will continue to be accepted, the Meeting will have guorum and the election will be conducted. Accurate Voting Services will be present to open the ballots and tabulate the votes. The candidates for the Board are:

# OCA SAR By Carol Mason LIDO'S **PARKING PIONEER**

Parking is a subject that is often on the mind of Lido Isle residents, especially on Tuesdays and Fridays. But did you know that Lido Isle was once the home of a Los Angeles parking luminary? Andrew Pansini (1891-1958), who lived with his wife Mary Catherine at 808 Via Lido Nord during the 1950s, opened the first parking lot in downtown Los Angeles in 1917.

The Pansini story is really the story of the American dream. Andrew was born as Andrea in Molfetta, Italy, in a family with eight children. When his parents died, the nine-yearold Andrea became a shoemaker's apprentice, eventually opening his own shoemaking business at the age of 15. His skill as an innovator became evident early with his invention of a new type of ladies' shoe that had a ringing bell in the heel! Talk about making an entrance!

Andrea then decided to follow family members to the United States where, as Andrew, his first job involved working in a general store in New Jersey. There he met his wife, the former Mary Catherine Hoffman (1892-1975), who was a bookkeeper for the same

business, and they soon started a family. When his involvement with a local dairy business in New Jersey didn't work out, Andrew set out for California, where he would soon make his mark.

Andrew arrived in LA in 1916 with 11 cents in his pocket. He talked himself into a job in the dairy business again and soon expanded his business interests into running a small taxi company (with his \$50 Studebaker car) while working as a soda jerk (what a quaint term!) on the side. The family's next pursuit was operating a fruit stand at the corner of 9th and Broadway in downtown LA.


In the course of running the downtown fruit stand, Andrew noticed a man who was waving cars to the side of the road, where he would watch the cars for 10 cents as the drivers went about their errands. Andrew thought he could improve on this business model by actually offering people vacant land on which they could park their cars. He soon became the lessor of land at the corner of 4th St and Olive, where he established the first parking lot in LA. He charged a flat rate of five cents a day. Not that success was

immediate. It took him days before he got his first customer, and that customer, taking full advantage of the lot's flat rate, stayed until midnight (although he did give Andrew a 20-cent tip)!

Andrew's parking lot business soon took off under the name of Savoy Auto Parks. Between 1920 and 1945, Pansini tore down 85 buildings in LA and turned the vacant lots into parking lots. A local newspaper of the time noted that readers should "Look out for Andrew Pansini or he'll be wrecking the whole of Los Angeles." Some have noted, however, that Andrew's business provided facilities that allowed LA to reach its growth potential at this pivotal time in its history

Andrew's time in Montebello and Lido Isle, as well as his further business pursuits. In the meantime, if you can't wait, there are two books that have been published about Andrew's life. The first, written by Andrew's daughter, Mary Elizabeth Pansini La Haye (also once a Lido Isle resident), is entitled It Started With a Nickel. The second book, written by Andrew's grandson, Andy Pansini, is entitled "Fathers of Invention: An American Story of Family, Faith and Innovation". Thanks so much to Andy Pansini for his help with this article.






